


















AUTO LPG: STATION SPREAD. PSUs LEAD.








Fleet Size, 2.5 m+? Aftermarket dominates























What's changed for India...

- Lower international prices have ensured a higher delta with Petrol maintained at almost 50%
- MS and HSD price decontrol resulted in Auto LPG being cheaper than diesel in running costs





Why Auto LPG..???

- The 'Auto LPG' Value proposition
 - Wide Availability. <u>500 + Cities</u> covered..
 - High Petrol Auto LPG Difference..
 - Cheaper than Diesel
 - Auto LPG is a low hanging fruit. Auto LPG Infrastructure can be set up almost immediately.
 - Lower Costs of Infrastructure and conversion
 - Cost of an ALDS is just at Rs 40 Lacs
 - Cost of LPG conversion kit is about Rs 20,000 for 4 wheeler






What's changed Globally...since 2014??

- The Effect of US Shale
 - From being world's largest LPG importer, USA, today is the world's largest LPG exporter
 - Global glut of more than 10 million tonnes in 2015
 - Excess of almost 20 million tonnes in 2017
- Continued pressures on global LPG pricing
- From a high of more than \$1200/t, LPG rates have been consistently around \$500/t

The EV narrative...

- Government Push...
 - Policy intent to push all new vehicle sales to EVs by 2030, though rhetoric has been consistently brought down...
 - FAME programme not having been able to catalyze early adoption..
 - Though some reports indicate that India will cross the 25% mark only by 2040, rather than 2030, disruptions like that in the adoption of Solar Power is possible.
- Issues remain...
 - Ad hoc policy support
 - Lack of access to reliable charging infrastructure
 - Inability of discoms to invest in charging stations for poor fiscal health.





The EV narrative...

- Are EVs really clean...at present?
 - 67% electricity in India produced from fossils...
 - Every unit consumed shall only add to emissions...
 - Moving the emissions from the cities to the power plants...
- FAME II funding
- Rewarding Transport Consumption, to mostly convert to EVs in 10-12 years...?
